- Hearing conservation
- Common injuries and hazards

The role of the COSS will vary from setting to setting, but the COSS program will help to prepare safety coordinators for all types of application. You will gain experience in:

- Effective safety committees
- Delivering safety training
- Accident investigations
- Worker's compensation claims
- Safety rules & regulations
- Emergency response plans
- Evaluating effectiveness
- Developing a written safety plan
